Please allow this letter to serve as our request for approval of transfer of control of the above-referenced license, currently held by R.D. Zande and Associates, Ltd. Following is the information we understand is required to process this request:

1. Description of the Transaction:

Stantec Consulting Services Inc. purchased all of the issued and outstanding shares of The Zande Companies, Inc. on January 2, 2008. R.D. Zande & Associates, Ltd. is a wholly owned subsidiary of The Zande Companies, Inc. The Zande entities are in the process of being wound up. R.D. Zande & Associates, Ltd., will be wound up following approval of transfer of the above-referenced license or issuance of a new license, as required. All operations will be continued under the name of Stantec Consulting Services Inc.

2. Changes in Personnel or Duties Relating to the Licensed Program: There will be no changes in personnel or duties relating to the licensed program. Jay Marsh will remain as the RSO.

3. Changes in Organization, Location, Etc.: There will be no changes in the organization, location, facilities, equipment or procedures relating to the licensed program. All operations will continue uninterrupted at the licensed location.

4. Status of Surveillance Program: A physical inventory and leak test is conducted at every 6 months. All required surveillance has been performed, documented, and reviewed, and is current to date. There have been no leaking sources identified to date.

5. Records transfer: All records concerning the safe and effective decommissioning of the facility have been transferred to the control of Stantec Consulting Services Inc., and will be kept at their current location of One Moore Avenue, Buckhannon, WV 26201, which shall continue as a business location of Stantec Consulting Services Inc. Stantec Consulting Services Inc. agrees to maintain these records in the same manner and location and as required by law. Stantec Consulting Services Inc. is knowledgeable regarding the extent and levels of contamination and


