Per the Contracting Officer's verbal approval on 12/21/07, the purpose of this modification is to (1) increase the contract ceiling by \$9,000.00 from \$1,351,738.50 to \$1,360,738.50 and (2) extend the period of performance for one month through 1/31/08. Accordingly, the following changes are hereby made:

1. Section B.3 CONSIDERATION AND OBLIGATION. This modification increases the contract ceiling by \$9,000.00 from \$1,351,738.50 to \$1,360,738.50. Accordingly, the first sentence in paragraph (a) and (b), first sentences are revised to read as follows:

(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$1,360,738.50.

(b) The amount presently obligated with respect to this contract is \$1,360,738.50.

2. Section B.11, DURATION OF CONTRACT PERIOD, is revised to read as follows:

The ordering period for this contract shall commence on September 29, 2004 and will expire on January 31, 2008. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18 - Ordering.)

All other terms and conditions remain the same.
