Leah Morrell, BWXT Licensing Manager and Beth Collins (attorney for BWXT) called me this morning to clarify that the press release concerning the name change, BWXT Nuclear Operations Division (BWXT Nuclear Products Division) is not true. The company is going through a legal restructuring and not all of the four groups have changed their names as the press has stated. BWXT Nuclear Operations Division has not yet changed its name. They will not do so until it has met all its legal requirements, to include the NRC's and other contract requirements. Beth Collins said that they anticipate to change its **name mid to late December 2007**. Leah Morrell requested that NRC email her the RAIs related to the name change license amendment change when they are ready so that BWXT can address them as soon as possible.
