BWX Technologies Inc. in the "current organization" as well as the "new organization" is and will remain the holding company for license SNM-42.

Within the current organizational structure, the Nuclear Operations Division (NOD) is not a separate company. It is a division of BWX Technologies Inc. The restructuring of the current organization incorporated NOD into the new "Babcock & Wilcox Nuclear Operations Group", with BWX Technologies Inc. remaining as the holding company.

With respect to the current organizational chart, NOD is a division of BWX Technologies Inc.. There are three separate plants within this division. With respect to the new organization, as indicated above, the restructuring of the current organization incorporated NOD into the new "Babcock & Wilcox Nuclear Operations Group", with BWX Technologies Inc. remaining as the holding company. The entities listed below the Babcock & Wilcox Nuclear Operations Group, Inc. are divisions/plants of the newly incorporated entity. SNM-42 will remain the license for Babcock & Wilcox Nuclear Operations Group, Lynchburg, Virginia and Babcock & Wilcox Technical Services Group, Inc. All financial instruments will remain under the BWX Technologies Inc. holding company. The three other divisions listed under Babcock & Wilcox - Barberton, Ohio; Mt. Vernon, Indiana; and Euclid, Ohio are not licensed facilities and not within NRC's jurisdiction nor a part of SNM-42.

The LTC is part of BWXT Services, Inc. and has been renamed to Babcock & Wilcox Technical Services Group, Inc. This entity is a subsidiary of the parent company BWX Technologies Inc. The change to this organization was name only.

With respect to SNM-2001, this entity is a separate company and not a part of the current NOD or SNM-42.
