WRITTEN EXAMINATION PERFORMANCE ANALYSIS

2007 ILT SRO(U) Retake NRC Exam Administered 10/03/07 Exam Analysis

Exam Score: Upgrade SRO Score – 80%

Performance Analysis:

All missed exam questions were reviewed with the applicant to determine if there were any problems with question wording or deficiencies in the training program. There were 5 questions that were missed by the SRO(U) applicant. A detailed review was performed to determine question validity. The results of the review are as follows:

Question 5: This question required the application of EOPs to determine if adequate core cooling existed. The candidate chose "B" due to an error in EOP usage. The candidate agrees the question is acceptable and no changes are recommended for this question.

Question 8: This question asked for the procedural requirements associated with a short reactor period. The candidate failed to recognize that a short period alarm was received which resulted in not recognizing an Event Notification needed to be made. This resulted in the candidate choosing "D". The candidate agrees the question is acceptable and no changes are recommended for this question.

Question 13: This question asked for Technical Specification application with HPCI and a leaking SRV. The candidate Chose "B" because of failing to include HPCI when determining which TS action was required to be entered. The candidate agrees the question is acceptable and no changes are recommended for this question.

Question 14: This question asked for procedures required to be entered for a complete loss of Y-30/Y-80. The candidate chose "A" because of failing to recognize that a loss of Y-30 would result in a lock on both feed water regulating valves. The candidate agrees the question is acceptable and no changes are recommended for this question.

Question 16: This question asked for Technical Specification requirements for a missed surveillance requirement. The candidate chose "B" because of failing to apply the allowances correctly if an acceptable risk assessment has been performed.

SUMMARY:

The exam analysis results identified zero program deficiencies and zero program enhancements to be made. Overall the candidate believes the exam questions were clearly written, technically accurate, and operationally valid.
