APPLICANT: MITSUBISHI HEAVY INDUSTRIES (MHI)
FACILITY: US-APWR DESIGN CERTIFICATION APPLICATION
SUBJECT: SUMMARY OF THE APRIL 18, 2008, PUBLIC MEETING BETWEEN MHI AND
THE U.S. NUCLEAR REGULATORY COMMISSION TO DISCUSS THE USE
OF GAS TURBINE GENERATORS

On April 18, 2008, a Category 1 public meeting was held between the U.S. Nuclear Regulatory Commission (NRC) staff and MHI at NRC Headquarters in Rockville, Maryland. During this meeting, MHI conducted a seminar on the gas turbine generators (GTG) that are part of the US-APWR design certification application. A list of meeting attendees is provided as Enclosure 1. MHI's presentation is shown in Enclosure 2. The NRC staff's questions about the gas turbine generator, which were presented to MHI before the meeting, are shown on Enclosure 3. These handouts can be accessed through the Agencywide Documents Access and Management System (ADAMS) Accession Numbers ML081130514 and ML081130515.

MHI opened its presentation by providing the reasons for using the Kawasaki GTG. MHI stated that the typical gas turbine generator is a very simple rotating engine with fewer parts than a diesel generator, the GTG do not require water for cooling the engine, and they have a higher level of reliability than the diesels. However, the GTG have a 40 second starting time as opposed to the diesel generators that have a 10 second starting time. The GTG that will be used in the US-APWR reactor design are rated at 4500 Kw for 1100 engine hours with an intake temperature of 115 degrees F, or 4950 Kw for 300 engine hours with an intake temperature of 115 degrees F. MHI then presented the layout of the GTG system, including the engine, the governor, the starting air system, the cooling system, and the piping system.

After the completion of its presentation, MHI discussed the NRC staff's questions, shown on Enclosure 3. The NRC staff and MHI engaged in a followup discussion regarding the diversity of the electrical system and whether the GTG had received adequate startup testing.
