SUBJECT: SUMMARY OF PUBLIC SCOPING MEETING CONDUCTED
RELATED TO THE REVIEW OF THE NORTH ANNA POWER
STATION, UNIT 3 COMBINED LICENSE APPLICATION

The U.S. Nuclear Regulatory Commission (NRC) staff conducted an environmental scoping meeting related to the review of the North Anna Power Station (North Anna) combined license application (COL) submitted by Dominion Virginia Power (Dominion). A public meeting was conducted on Wednesday, April 16, 2008, at the Louisa County High School, 757 Davis Highway, Mineral, Virginia. Approximately 250 people attended the meeting. The participants included members of the NRC staff, NRC contractors from Pacific Northwest National Laboratory, members of the public, representatives from Dominion, the news media, and local government officials. Public comments and questions were mainly focused on the COL process, socioeconomics and environmental impacts to Lake Anna water quality, recreation and tourism.

The purpose of the meeting was to provide the public with an opportunity to participate in the environmental scoping process by providing comments on any issues the public thought the NRC staff should consider while preparing a supplemental environmental impact statement for the North Anna COL application. During the meeting the NRC staff presentation outlined the overall licensing process under 10 CFR Part 52; provided a description of the National Environmental Policy Act of 1969 review process; discussed the environmental requirements outlined in 10 CFR Part 51; and addressed how these requirements would be implemented during the North Anna COL review.

A list of attendees for the meeting is provided in Enclosure 1. Enclosure 2 is a copy of the meeting handouts including the agenda, open house form, and Federal Register Notice. Enclosure 3 is a copy of the NRC slide presentation.
