Andrea,
Below is a draft schedule for our safety audit in Frederick. Please convey to Bechtel that our groundwater and surface water experts will be available both days, so the particular order of the discussions does not matter to us. Please note that my paragraph under April 8 was conveyed to Tony Banks on the 3/20 conference call.

April 8

A list of information needs will be sent. In general the NRC would like Dominion to have SMEs available to discuss of 2.4.12 (groundwater), 2.4.13 (groundwater and Visual MODFLOW), and 2.4.2 + 2.4.10 (stormwater and HEC-RAS) sections of the FSAR. NRC will want to review the calculation packages that support values presented in these subsections. NRC will also want to discuss any steps taken by Dominion to determine if any new & significant items exist since the ESP documents were finalized.

April 10

- Late morning or just after lunch: Meet with **Dominion and** Bechtel staff at their Frederick Offices.

April 11

- All day: Meet with **Dominion and** Bechtel staff (Frederick) until our review is complete.

April 14

- Cook, Tiruneh, McBride, and PNNL staff will attend the site tours offered as part of the Environmental Audit.
