SUBJECT: Summary of Telephone Call with Applicant on March 4, 2008

On March 4, 2008, NRC staff (T. Kevern, J-C Dehmel, T. Frye, A. Johnson) participated in a telephone conference call with Dominion representatives (G. Borsh, J. Hayden, et al) regarding the staff's detailed review of the North Anna Unit 3 COL application. The purpose of the call was to discuss technical topics which may lead to requests for additional information (RAIs).

The discussion focused on the staff's inquiries regarding the manner in which the North Anna COLA either directly, or through the incorporated-by-reference ESBWR Design Control Document, addressed the provisions of Appendix I to 10 CFR 50. At the conclusion of the call, staff informed Dominion that an RAI would be forthcoming on this topic.
