

The following additional information is needed to review your request. Please note, we cannot authorized the release of your "old" storage area located at 4730 Frederick Avenue, St. Joseph, Missouri, until we have received and reviewed a copy of the results of your close-out survey. The close-out survey needs to include the following information:

- a. Please list the radionuclides that were actually used or stored at the "old" storage site.
- b. Please submit information on any leaking sealed sources used or stored at the "old" storage site. Information needs to include the isotope, amount of leakage, contamination of other areas or personnel, description of the cleanup, and disposition of the source(s). If you did not have any leaking sources, please state so. Please submit a copy of the leak test that was current when the sealed sources were moved to the "primary" storage location at 212 North Buchanan Street, Maryville Missouri. Also, as we discussed by telephone on April 23, 2008, please send the most current leak test for the sealed sources.
- c. Please confirm that all radionuclides have been removed from the "old" storage facility and transferred to the "primary" storage area.
