Thank you for your letter dated March 30, 2008 [postmarked April 8, 2008] and received April 11th. This will confirm that XBL is maintaining \$225,000. + in an insured U.S. government securities account, and has these funds as part of a trust fund consistent with previous standby trust agreements [NOT an escrow fund] dedicated for use as called for by the NRC. XBL is revising its submission documents to NRC to correctly reflect the type of funds, and acceptable trust fund components, with suitable trustee documentation. We plan to provide you with the corrected, updated financial assurance documents before the end of May, 2008.

XBL appreciates your assistance and guidance. 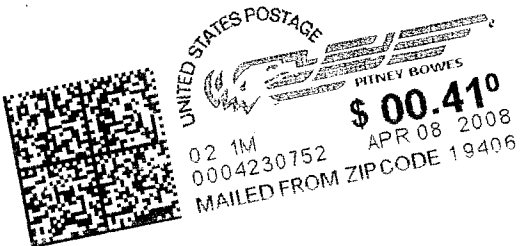
