Subject: Response to NRC Inspection Report 030-32803/07-001 and Notice of Violation

This letter is in response to the NRC Notice of Violation issued on April 18, 2008. The two violations that were noted have been addressed as follows:

A. Condition 11.B in Amendment No. 06 of NRC License 53-29043-01

The current RSO for Masa Fujioka & Associates has been amended through Mr. Roberto Torres of the NRC on January 7, 2008. MFA's materials license now states Jayson S. Mitsuyoshi as the new RSO. MFA will in the future update the NRC when a new RSO is named.

B. Condition 11.A in Amendment No. 06 of NRC License 53-29043-01

Former MFA employee and RSO William Lyon conducted a nuclear gauge class with all unlicensed gauge users on January 2, 2008. The class included gauge use and safety, security, transportation and storage requirements, RSO duties, emergency procedures and contacts, documentation, and regulatory dose rates and limits. Mr. Lyon received RSO training from CPN International on October 30, 2002.

MFA's current RSO Jayson Mitsuyoshi, is awaiting RSO training from Maurer Technical Services the next time they are in Hawai'i (usually October). Upon completion of this training, MFA will inform the NRC and provide documentation.

Also, contrary to the violation report Mr. Mitsuyoshi does possess a bachelor's degree in a physical/life science, or engineering.

MFA has had contact with the NRC through Mr. Richard Leonardi and Mr. Roberto Torres, and has followed their recommendations to correct the situation. If there are any questions please contact Jayson S. Mitsuyoshi at (808) 484-5366.


