The Certification of Financial Assurance did not include license condition 29 of License No. 32-12358-01 on the certification. This license condition is important because it limits the amount of unsealed materials such that you may use a prescribed value. Please include this condition as it applies to the material listed on your Certification of Financial Assurance.

Since the amount of sealed materials on your license do not require financial assurance, you do not need to list them on the certification.
