I. INTRODUCTION

This procedure identifies the compilation of documents describing the Agreement State program.

II. OBJECTIVES

- A. To provide a central reference point for all documents that collectively describe the Agreement State program as authorized by Section 274 of the Atomic Energy Act of 1954, as amended, and the Energy Policy Act of 2005.
