Gentlemen:

The purpose of this letter is to inform the NRC that, pursuant to the applicant's responsibilities in 10 CFR 2.101(a)(3)(ii), Progress Energy – Carolinas (PEC) has transmitted a copy of the application accepted for review by the NRC to the county executive in the county in which the proposed Shearon Harris Nuclear Power Plant Units 2 and 3 may be located.

Also, pursuant to 10 CFR 2.101(a)(3)(ii), PEC has notified executives of counties in which alternative sites were located that a copy of the application as accepted by the NRC for review is available. The notice of availability included the following information: Docket number of the application; a brief description of the proposed site and facility; the location of the site and facility as primarily proposed and alternatively listed; the name, address, telephone number, and email address of the applicant's representative who may be contacted for further information; notification that a draft environmental impact statement will be issued by the NRC; and notification that if a request is received from the appropriate chief executive, the applicant will transmit a copy of the application and environmental report, and any changes to these documents which affect the alternative site location, to the executive who makes the request.


