Desc: Background: On or about July 1 or July 2, 1976, in my capacity as then Executive Director of the Southern Africa Project of the Lawyers' Committee for Civil Rights Under Law, I and my co-counsel (Mrs. Goler Teal Butcher) filed a Motion to Intervene in a matter then pending before the NRC in which a South African or American company was requesting a license to permit the export from the U.S. back to South Africa of a certain quantity of highly enriched uranium fuel rods. The rods had been imported into the U.S. pursuant to a license for uranium enrichment processing.

The Motion to Intervent was filed on behalf of a group U.S. Congressmen and women, as well as on behalf of several South African political refugees then residing in the United States. The Motion was supported by a detailed Legal Memorandum and by a substantial volume of official U.S. Government and South African Government documents. Many of those documents had previously been classified as "CONFIDENTIAL" or "SECRET" but had subsequently been declassified and released by the U.S. Department of State pursuant to a FOIA request previously submitted by the Lawyers' Committee.

Waiver_Purpose: I intend to use this information for historical documentation, academic analysis, and public information purposes, all three being of co-equal importance.

Waiver_ExtentToExtractAnalyze: I intend to rely substantially on the substantive content of any records released for the purposes set for in question 1 above.

Waiver_SpecificActivityQuals: As one of the authors of the Motion to Intervene and the Legal Brief, and as the person who filed the FOIA request that led to the release of previously classified information used to support the Motion to Intervene, I consider myself uniquely qualified to use the information for the intended use in a way that will contribute to public understanding of what occurred. Also, my co-counsel in the case is no longer alive and I know would wish for me to carry out this subsequent work on our joint project.
