SUBJECT

Control No. 316967 – Re - Amendment request (NRC License No. 24-03060-01) by letter dated February 8, 2008 (with attachments), regarding the recent transfer/disposal of 9 gauges to Ohmart/Vega, a licensed and certified contractor, and the receipt of 2 replacement gauges, all containing sealed sources of Cs-137, ranging in activity from 20 millicuries to 300 millicuries each.

SUMMARY

In a telephone conversation with Mr. Hoac on this date, the amendment request described above was discussed and Mr. Hoac stated or confirmed the following:

1. The licensee no longer possesses any, and is requesting deletion from the license, of Kay-Ray Model 7062BP gauges as well as Ohmart Model SR-1 (also designated as ED-12) gauges. Further, the only gauges remaining in their possession are Ohmart Models SH-F1A (one with 15 millicuries Cs-137), SHRM-PA (three with 100 millicuries Cs-137 each and three with 10 millicuries Cs-137 each), SHLG-1 (three with 50 millicuries Cs-137), SHRM-PA (three Cs-137 each and one with 20 millicuries Cs-137), SHLG-2 (one with 20 millicuries Cs-137), and Kay-Ray Model 7062B (one with 50 millicuries of Cs-137). Although total current possession is 585 millicuries, the license requested a total possession limit of 800 millicuries to allow for replacement sources or limitted expansion involving make and model of gauges already authorized on the license.

2. Also. Mr. Hoac confirmed that the licensee has never had in their possession any of these gauges which developed a leaking source, as confirmed by routine leak test analysis.

3. Mr. Hoac also confirmed that the serial number of the source listed as S96B0501 in their letter dated February 8, 2008, is incorrect and that the correct serial number is S96B2901.

ACTION REQUIRED

License reviewer to utilize above information in evaluation of subject amendment request.
