Bart chairs a committee hearing examining the challenges of E-waste. The House Science and Technology Committee held a hearing April 30 to review the challenges facing the disposal and recycling of waste electronic equipment, or E-waste.

According to the Government Accountability Office, about 100 million TVs, computers and monitors become obsolete every year. While some materials in E-waste are potentially hazardous, others are quite valuable.

Nuke Waste Issue Heats Up

I am requesting congressional hearings on legislation I introduced to ban the importation of foreign nuclear waste into the United States. The Nuclear Regulatory Commission is accepting public comments on a Utah-based company's application to import 20,000 tons of nuclear waste from Italy, process it in Tennessee and dispose the remainder in Utah.
