To the NRC:

As a U.S. citizen, concerned with the accumulation and distribution of nuclear waste in our country, I am appalled that the NRC would consider granting a license to EnergySolutions (or anyone else) for the importation of nuclear waste. I urge the NRC to deny license applications IW023 and XW013.

This plan to import 20,000 tons of waste has many potential and unnecessary dangers, could increase radiation exposures to the public and the environment, and would set an extremely undesirable precedent. The United States must not become the dumping ground for the world's radioactive waste - particularly when we can not yet deal effectively with our own.

These applications and any future applications must be rejected and a national policy must be set that no importation of nuclear waste will occur.
