The enclosed Confirmatory Order is being issued to Nuclear Fuel Services, Inc., as a followup to the Alternative Dispute Resolution (ADR) mediation sessions with the Nuclear Regulatory Commission (NRC) of September 28 and November 30, 2006.

We note that, pursuant to Section 223 of the Atomic Energy Act of 1954, as amended, any person who willfully violates, attempts to violate, or conspires to violate, any provision of this Confirmatory Order shall be subject to criminal prosecution as set forth in that section. Violation of this Order may also subject NFS to civil monetary penalty.
