On March 14, 2008 (Reference 1), UniStar Nuclear Energy submitted the remaining portions of the Calvert Cliffs Nuclear Power Plant (CCNPP Unit 3) Combined License (i.e., COL) application to the NRC.

During a telephone conference call between NRC and UniStar Nuclear representatives on April 29, 2008, the NRC identified issues with Part 5 (Emergency Plan) and Part 11H

(State and Local Emergency Plans) of the COL application that required prompt resolution. This letter provides:

1. Revised CCNPP Unit 3 Emergency Action Levels (EALs) consistent with NEI 99-01, Revision 5. These EALs replace the EALs previously supplied in Reference 1.
2. Revisions to the emergency plans for the State of Maryland, Calvert County, Dorchester County, and St. Mary's County. These plans replace those previously submitted in Reference 2. The current status of the state and local emergency plans are as follows:

The officials from St. Mary's County, Maryland have requested that their emergency plan be withheld from public disclosure due to sensitive unclassified non-safeguards information (SUNSI) contained within it. This plan has been appropriately marked and we request that it be withheld from public disclosure in accordance with 10 CFR 2.390(d).

In addition, UniStar Nuclear is working with the District of Columbia, Commonwealth of Virginia, State of Delaware, State of Maryland and the counties of Calvert, Dorchester, and St. Mary's to obtain Certification Letters that comply with 10 CFR 52.79(a)(22)(i). The revised Certification Letters are expected to be submitted by June 30, 2008. UniStar Nuclear will work closely with these agencies to obtain this information by this date.

Finally, UniStar Nuclear identified that the Calvert Cliffs Nuclear Power Plant Emergency Response Plan Unit 3 Annex and the January 2008 District of Columbia Certification

Letter were not submitted in Reference 1 due to an administrative oversight. As such, the Calvert Cliffs Emergency Response Plan Unit 3 Annex and the January 2008 District of Columbia Certification Letter are included in this supplement.
