1. The ceiling for the base year is hereby increased by \$12,156.77 from \$39,848.47 to \$52,005.24. The total value of this contract is hereby increased by \$12,156.77 from \$80,786.70 to \$92,943.47.

2. FY2008 funds are hereby obligated in the amount of \$10,000.00. Funding is increase by \$10,000.00 from \$39,848.47 to \$ 49,848.47.
