In accordance with Section G.4, Task Order Procedures, of Contract No. NRC-42-07-036, this definitizes Task Order No. 32. The effort shall be performed in accordance with the attached Statement of Work.

Task Order No. 32 shall be in effect from date of award through thirty months, with a cost ceiling of \$176,030. The amount of \$168,325 represents the estimated reimbursable costs, and the amount of \$7,705 represents the fixed fee.

The amount obligated by the Government with respect to this task order is \$130,000, of which \$124,046 represents the estimated reimbursable costs, and the amount of \$5,954 represents the fixed fee.

The issuance of this task order does not amend any terms or conditions of the subject contract.


