On July 2, 1976, a petition for intervention on behalf of Congressman Charles C. Diggs, et. al., in the matter of the application of U.S. Nuclear, Inc., for a license to export special nuclear material to South Africa, XSNM - 690, Amendment 2 (Docket No. 70-1853) was filed by former co-counsel T. Michael Peay and Mrs. Goler T. Butcher.

In a communication from your office dated April 4, 1977, to Mrs. Butcher, you indicated, inter alia, that the Commission intends to rule on this petition for intervention after it has received the final views of the Executive Branch respecting the proposed export.

On July 18, 1977, I served notice, in accordance with 10 C. F. R. §2.713 (a), of my appearance as counsel on behalf of the intervenors in this proceeding following the withdrawal of former co-counsel Peay and Butcher.

I would respectfully request some indication as to the current status in the Commission of the petition for intervention on behalf of Congressman Charles C. Diggs, et al. I specifically request that petitioners be furnished copies of all communications (1) from
