This letter and the enclosed NRC Form 591M refer to the inspection conducted on April 24, 2008, at your facility in Kailua, Hawaii, with continued in-office review through May 13, 2008. This inspection was an examination of activities conducted under the authority of Byproduct Materials License 53-16929-01 as they relate to safety and compliance with the Commission's rules and regulations and with the conditions of the license. Within these areas, the inspection consisted of a selected examination of procedures and representative records, observation of activities, independent radiation measurements, and interviews with personnel. At the conclusion of the onsite inspection, a preliminary exit briefing was conducted with Mr. Brian Matsusaka and you to discuss the inspection findings. A final exit briefing was conducted telephonically with Dr. Chuong Nguyen and Mr. Matsusaka on May 13, 2008.

Within the scope of this inspection, no violations were identified; therefore, no response to this letter or the enclosed NRC Form 591M is required.
