


The purpose of this modification is as follows:

1. To extend the period of performance at no additional cost to the Government to allow for sessions of the "Principle Centered Leadership" and "7 Habits Signature Facilitated Workshop" training courses to be received by staff of the Office of Information Services (OIS).
2. To change the Project Officer.

Accordingly, the following revisions are hereby made:

(1) (a) The first sentence in the second paragraph in Block 20, Schedule of Supplies or Services, on Page 1 of the delivery order is revised as follows:

TO:

"The period of performance is 33 months, from May 17, 2006, through February 16, 2009."
