
14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)  
 The purpose of this modification is to exercise optional task 3, thereby increasing the contract ceiling by \$6,952.20 from \$39,798.80 to \$46,751.00. Accordingly the Contract is modified as follows.

Refer to Section A.2 entitled, "Consideration and Obligation - Cost Reimbursement (June 1988)" paragraph (a) is deleted in its entirety and replaced with the following:

"(a) The total estimated cost to the Government for full performance under this contract is \$46,751.00"
