

Dear Jim,

Per my conversation with Kathy Modes of May 27, 2008, I am requesting an expedite amendment of our License.

Our license authorizes us to install and service our gauges at the customer's facilities. Up to this day I had to go to the customer in order to get any problem electronically or mechanically fixed at the source housing.

Most of our customers do not obtain their own material license and are therefore restricted in dealing with the source housing. They do not have the ability to take it of the gauge or even ship it. Because of that a service of the source housing was only possible at the customer's facility.

Now I have a customer, who is requesting the repair to be done at our NJ office and is planning to ship the source housing.

Kathy does not see a reason why we can not service the source housing at our facility.

I am well trained in dealing with any kind of repair of the source housing. My dose reports from 1992 up to now do not show any received dose other than what applies to every person not involved in the work with radioactive material. This clearly indicates the safety of our device and that I am capable to protect not only my self put also other people further away from the hot zone.

I hereby request a expedite amendment of our material license 29-23394-01 (Docket No. 03-21015) by adding to condition 9. (5), "or betacontrol of America, Inc., 425 Route 202, Towaco NJ 07082" or simply by removing "Germany" from this condition if possible.
