Dear Ms. Moore:

We have reviewed the revisions to the Nuclear Fuel Services, Inc. (NFS) Fundamental Nuclear Material Control (FNMC) Plan for Special Nuclear Material of Low Enriched Uranium dated February 4, 2005 (NFS No. 30G-05-0107). Under the provisions of 10 CFR 70.32(c), NFS submitted Section 3, Revision 6; Section 4, Revision 5; Section 5, Revision 4; Section 8, Revision 3; and Annex, Revision 5.

The changes were mainly administrative in nature, including: correction of typographical errors and update of management titles, procedure titles, and organizational chart. The staff review confirms that the changes submitted by NFS meet the requirements of 10 CFR 70.32(c) in that none of the changes decrease the effectiveness of the material control and accounting program or the measurement control program, implemented pursuant to 10 CFR Part 74, Subpart C.


