Gov. Rendell To Take Action Over Sleeping Guards

(CBS 3) PHILADELPHIA Governor, Ed Rendell says he's 'appalled' by images of nuclear power plant guards sleeping on the job.

Rendell promises to take strong action to make sure Pennsylvania's nuclear power plants are being properly protected.

"I was appalled. I was appalled because something like this really shakes public confidence," said Gov. Rendell.

To find out if other guards are sleeping inside Pa. power plants, the Governor plans an immediate increase in surprise visits by state inspectors and a meeting with federal officials in the nuclear regulatory commission.

"We're going to talk to the N.R.C., figure out what is going on and see what measures we can take to ensure that these guards are on their toes at all times. There should be video surveillance of the guards themselves, it's an easy thing to do," said Gov. Rendell.

The owner of the Peach Bottom, Exelon Nuclear said while sleeping guards are unacceptable, they posed no risk to public safety.

Exelon has now terminated the contract of Wackenhut security, which provided protection at Peach Bottom.

The whistleblower, who videotaped the sleeping guards, said he hoped the response will lead to safer nuclear plants.

The whistleblower asked that their identity be concealed.

"It's not just my life that's in danger, but my family, my friends and the communities that live around it," said the whistleblower.
