On March 13, 2008, the U.S. Nuclear Regulatory Commission (NRC) requested your comments concerning the proposed import license application IW024. AREVA NP Inc., requested permission to import one 55-gallon drum containing up to 60 kilograms of Class A radioactive waste in the form of contaminated protective clothing, rags, metal shavings and rejected parts. The waste was generated from the machining process on the DC Cook power plant (Michigan, U.S.) reactor coolant pump internals during refurbishment in France. EnergySolutions, located in Oak Ridge, Tennessee, has agreed to accept the waste provided AREVA satisfies the NRC import requirements. Per a recent conversation between you and Mr. Stephen Dembek of NRC's Office of International Programs, regarding this request, I am enclosing written confirmation from Mr. Donnie Brackett, EnergySolutions/Duratek, that residues from processing waste imported under IW024 would be attributable to EnergySolutions/Duratek and disposed of at the EnergySolutions' Clive, Utah disposal facility.
