Please find enclosed a letter from the ABR showing that Dr. O'Keefe's ABR Certificate is being modified to show that he is AU Eligible, NRC Form 313(AUD) filled out and signed by Dr. O'Keefe's preceptor, Dr. Lawrence Ricci and NRC Form 313(AUT) filled out with documented cases in section 3(c) and signed by the same preceptor. Dr. O'Keefe has the necessary cases to be authorized for 35.392, but not for 35.394. Therefore, he will be under the supervision of one of the physicians that are on our license for 35.300 until he has the necessary number of cases, and then that physician will sign his preceptor forms and another amendment request will be made.
