Gentlemen:

Pursuant to the Code of Federal Regulations, Title 10, Part 30 "Rules of General Accountability of Licenses of By-Product Material" requests an amendment that By-Product Materials license number 19-12667-01 be amended to designate T. O. Ziebold as Radiation Protection Officer.

This amendment is necessitated by the recent resignation from the company of J. J. Hairston who has been our Radiation Protection Officer.

The duties and responsibilities of the Radiation Protection Officer have been transmitted to the AEC with our initial license application (December 1967) and with a letter from T. O. Ziebold dated October 2, 1970. Dr. Ziebold's experience and qualifications were transmitted to the AEC by letter dated September 15, 1970.

It should be noted that Mr. O'Neil is not a full-time employee of Neutron Products, but acts as an independent health physics auditor reporting to the President. He will be expected to visit the company's facilities at least twice weekly to conduct surveys and to review current operations, and he will generally be available by telephone.

As an additional measure to assure radiological safety in the company's operations, we have established a Radiation Safety Committee to review, approve, and record safety evaluations of proposed operating procedures involving radiation or the handling of radioactive materials before such procedures may be implemented. The following personnel are members of the Radiation Safety Committee (their positions in the company are shown in the attached organization chart):
