Please amend our byproduct materials license number 13-02063-01 to add Methodist Cardiology Physicians, Methodist Medical Plaza I, 6920 Parkdale Place, Suite 107, Indianapolis, IN 46254, as an area of use for 35.100 and 35.200 materials and uses.

A diagram of this new area of use is attached. The clinic is located on the first floor of the Methodist Medical Plaza I as shown on the attached diagram (attachment 1). Only unit dosages of radiopharmaceuticals will be utilized at this location. All radioactive material will be delivered to and stored in the hot laboratory identified on the attached diagram (attachment 2). Radioactive material will be stored in the hot lab in lead containers and there will be a lead-lined waste container. An ionization chamber dose calibrator and a GM survey meter will also be present in the hot lab. The hot lab will be locked when not under direct supervision. All appropriate aspects of the Methodist Hospital radiation safety program will be observed for this new area of use, including routine quarterly audits by the Methodist Hospital Radiation Safety Officer. Radioactive material use at this location will be under the supervision of a Methodist Cardiology Physicians authorized user approved by the Methodist Hospital Radiation Safety Committee.



