The purpose of this modification is to revise the obligated amount reported on the previous modification (M004) to adjust for an administrative error that resulted from a miscalculation of the total obligated amount of \$132,215.04, as opposed to \$134,215.04, which reflects the correct total amount for the current obligated amount.
