The purpose of this contract modification is to: (1) exercise option year one in accordance with FAR Clause 52.217-9, OPTION TO EXTEND THE TERM OF THE CONTRACT, thereby extending the period of performance through March 26, 2009; and (2) provide funding in the amount of \$31,320.00 for Option Year Two (CLIN 004b, 005, and 006), thereby increasing the obligated amount from \$84,890.00 to \$116,210.00. Accordingly, the contract is hereby modified as follows:

1) Section F.2, DURATION OF CONTRACT PERIOD, is deleted in its entirety and replaced with the following:

"F.2 DURATION OF CONTRACT PERIOD

The ordering period for this contract shall commence on March 27, 2007 and will expire on March 26, 2009. Any orders issued within this period shall be completed within the timeframe specified in the order, unless otherwise specified herein. The term of this contract may be extended at the option of the Government for an additional 3 one-year options."

2) The obligated funds under this contract are hereby increased by \$31,320.00 from \$84,890.00 to \$116,210.00. Funds are obligated for CLINs 004b, 005, and 006. Per Section C.4 of the Statement of Work, exact course dates and locations will be arranged between the NRC Project Officer and the Contractor and confirmed by written delivery order.

All other terms and conditions of this contract remain unchanged.
