Gentlemen:

Please find enclosed the renewal of your NRC Material License.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the Region I Material Licensing Section, (215) 337-5239, so that we can provide appropriate corrections and answers.

Please be advised that you must conduct your program involving licensed radioactive materials in accordance with the conditions of your NRC license, representations made in your license application, and NRC regulations. In particular, please note the items in the enclosed, "Requirements for Materials Licensees."

This license limits the maximum amount of material that may be possessed at any one time rather than providing the unlimited authorization requested in your application dated February 14, 1986. If material in excess of the specified limits is required, then you must submit a request to amend this license and receive approval of new limits prior to taking possession of the material. You should assure that your inventory and control procedures are adequate to prevent possession of licensed material in excess of the limits in the license.

The areas used for storage of licensed material under this license at the Griffis Air Force Base in Rome, New York, and the Defense Construction Supply Center in Columbus, Ohio facilities are hereby released for unrestricted use. However, the Jeffersonville Depot in Jeffersonville, Indiana remains on the license as a place of use. You submitted the results of your close-out survey with the application for renewal, and requested release of this facility, but the NRC has not yet performed a confirmatory survey. We will amend your license to release the Jeffersonville Depot for unrestricted use upon completion of a satisfactory confirmatory survey.

Since serious consequences to employees and the public can result from failure to comply with NRC requirements, the NRC expects licensees to pay meticulous attention to detail and to achieve the high standard of compliance which the NRC expects of its licensees.
