General Comment

Firstly, let me point out one math error I found. Reference the line for Cs-137 for Appendix E. The values listed for Category 3 are 0.01 TBq or 2.7 Ci and for 1/10 Category 3, 0.001 TBq or 0.27 Ci. These are incompatible. I believe the TBq values are in error by a factor of 10.

Secondly, I believe revision of the rule may be premature because there is no operating source tracking system to date. When the original rule was promulgated, licensees prepared to enter data into a tracking system that did not then exist. The NRC finally issued a "not yet" notice as it became apparent the tracking system would not be ready by the required date. It would be an embarassment to the agency were this to happen again. Additionally, only by interfacing with this system can a reasonable estimate of impact to licensees be made.

Thirdly, while I support efforts to thwart potentially harmful illicit uses of radioactive material, I believe it unlikely that aggregation of sources to build up a significantly hazardous quantity is unlikely given the security typically associated with radioactive sources.
