Dear Office of the Secretary,

Herewith, I ask that the Commission deny EnergySolutions' request to import 20,000 tons of Italian nuclear waste into the U.S.

Based on numerous news reports, this single request is significantly larger than all previous import licenses granted by the Commission.

Granting the EnergySolutions request would therefore represent a serious departure in this country's policies for handling nuclear waste.

Further, granting this request would set a dangerous precedent for the U.S. to become the world's nuclear waste repository at a time when our own low-level waste disposal capacity remains uncertain.

Moreover, the transportation of this waste into our ports and through our cities and towns presents an unacceptable risk to our health, safety, and security.

I am advised that EnergySolutions states in its application that "the sources of this material are not fully known" and that some of the waste may be above allowable contamination levels for processing in Tennessee and disposal in Utah.

The Commission should not agree to allow this import when the nature and hazards of this material remain unclear.

Because of the concerns stated above, I strongly urge the Commission to reject the application submitted by EnergySolutions.
