Dear Senator Reid:

I'm interested in the Congress of the United States organizing inquiry into what I think is a frightening level of corporate big business outright violence intended to harm or even take the lives of private citizens, government employees, people who have jobs in the corporate sector: whenever they stand up against irresponsible corporation misconduct. I've attached to this letter a report from the Executive Director of the Forest Service Employees for Environmental Ethics about what he and their organization think was the unwarranted firing and harassing of a wildlife biologist named Glen Ith which was followed with what was probably invisible technological slaying of him, covered up as he dying of a heart attack.

Glen Ith was only doing his job. He reported wrongdoing of the United States Forest Service when they participated in and/or permitted illegal logging to begin in our what is supposed to be protected: Tongass National Forest in southeastern Alaska.

Our world cannot endure any more unnecessary, senseless assaults upon what is left of precious ecosystems, any of which sage leaders set aside to make sure that our planet had something left, enough natural biology to keep fresh air, clean water and every life form reliant upon it, from literally becoming something there is nothing left of.

I would like to know if you, Senator Reid, would get involved in important investigatory not just into the tragedy of what the logging industry did to Glen Ith, but look into what is probably organized activity within polluting industries that now is going beyond just requesting local, state and federal governments to permit the plundering of our natural resources.

Glen Ith will be a person all of us now look up to and remember as nothing less than a fallen hero. His courage must not be for naught. Making certain that those who stand up against the wanton, greedy corporate destruction of our natural world are not intimidated, harassed, terrorized or even harmed, is something that must become an important task of our leaders, in the United States and throughout the world.

On another topic: hydrogen must not be permitted in any of the development and research in new kinds of energy needed to power our homes, workplaces or to

propel vehicles: We just got hydrogen out of food processing. Hydrogen is far too toxic and dangerous to the health of the people for it to be permitted to fuel anything. Whatever the alternatives to fossil fuel burning polluting energy production, they must be hydrogen free.


