Insert personal comments here: : Dear Office of the Secretary,

I'm writing to urge the Nuclear Regulatory Commission to DENY EnergySolutions' request to import 20,000 tons of Italian nuclear waste into the U.S. It is my understanding that this single request is many times larger than previous import licenses granted by the Commission and would therefore represent a serious departure in this country's policies for handling nuclear waste.

Granting this request would set a dangerous precedent for the U.S. to become the world's nuclear waste repository at a time when our own low-level waste disposal capacity remains uncertain. Filling up our domestic resources for low-level waste disposal with another country's nuclear waste will put considerable pressure on existing U.S. disposal sites to expand and create a need for new sites to open up. Because of this, I strongly urge the Commission to REJECT the application submitted by EnergySolutions. Thank you.
