AN ACT

To amend and reenact R.S. 30:2113(D), relative to the Louisiana Nuclear Energy and
Radiation Control Law; to provide for prohibitions on transportation of certain
radioactive waste; and to provide for related matters.

Be it enacted by the Legislature of Louisiana:

Section 1. R.S. 30:2113(D) is hereby amended and reenacted to read as follows:

§2113. Transportation; regulations

* * *

D. Notwithstanding any law, order, or regulation to the contrary, no ~~high~~
~~level~~ high-level radioactive wastes, including spent fuel rods from nuclear reactors,
or nor any radioactive waste generated outside of the United States or its territories,
except such waste generated by the United States Armed Forces, shall be transported
into the state for disposal or storage in this state or elsewhere.
