The purpose of this letter is to withdraw the referenced letter, dated June 6, 2008.

By the referenced letter, TVA submitted responses to the NRC's information needs related to their review of the hydrology information in the Applicant's Environmental Report for TVA's combined license application (COLA) for Bellefonte Nuclear Plant, Units 3 and 4 (BLN). However, subsequent to submitting referenced letter, it was identified that an incorrect cover letter had inadvertently been provided with this letter. Although the correct enclosure and attachments were attached to the referenced letter, the cover letter identified the submittal as the response to NRC information needs related to reservoir vital signs monitoring reports and the Coal Gasification Project Environmental Impact Statement. Therefore, this letter withdraws the referenced letter. Another letter that provides TVA's responses to the NRC information needs relating to hydrology will be resubmitted under separate cover, as will a letter that provides the reservoir vital signs monitoring reports and the Coal Gasification Project Environmental Impact Statement.


