I am submitting a comment against the EnergySolutions license application - "License Applications Nos. IW023 and XW013 (Federal Register Volume 73, Number 28, 2/11/08)". EnergySolutions, with processing sites in Tennessee, is seeking a license to import up to approximately 20,000 tons of various types of materials from decommissioned nuclear facilities in Italy. The waste has been stored in Italy since the 1980s. The application should be denied because it contains insufficient data concerning the waste stream prior to and after processing by weight, volume, and radionuclide content; and EnergySolutions would process, and incinerate contaminated material at its Oak Ridge facilities resulting in some of the material ultimately being housed in low level (and sometimes deregulated) waste landfills. Tennessee leads the nation in nuclear waste processors, incinerators, radioactive "recycling" and release from control. The added cumulative impact of the activities requested in this application is overly burdensome to the citizens of Tennessee and should be an additional factor in denying this application.
