Hi Laura,

I have attached our comment tracking file for your information.

In summary:

- There are 25 separate tracking numbers, CCNP001 through CCNP025.
- There are 2 mass mailings, CCNP003 MM2 (2 total) and CCNP008 MM1 (102 total).
- One letter was received that had multiple authors (CCNP014).
- To date, I have received 7 officially stamped (with your date stamps and signatures, etc.) .pdf files. The last column on the tracking matrix indicates which stamped numbered files have been received.
- There are 2 worksheets on the attached file: 1) CC Tracking Matrix, and 2) Duplicate ML# Tracking. With regard to the latter; 3 of the comments (CCNP014, CCNP015, and CCNP016) came as .pdf's in both stamped and unstamped forms, each having a different ML#. I have highlighted these on the tracking matrix worksheet and summarized them on the duplicate ML# tracking worksheet. I suspect we can drop the unstamped versions from my tracking but I wasn't sure if you needed to know about the multiple ML#'s so I included them for you. (There used to be a few more but since you told me about the 9-digit ML number I was able to drop several of the files that came as multiples with a different 10th digit).

Things I'm not sure about:

- I am not sure how the mass mailings are going to be handled, that is, I'm not sure if they will all get the same ML# (since they all say the same thing) or if they will each be given a unique ML# (since they were sent separately from different commenters).
  - If mass mailings will receive unique ML#'s then there are 124 comments that need ML#'s. Do emails have to have an official receiving stamp? Sounds like a dumb question I know.
  - If the mass mailings will be handled with a common ML#, then there are 18 comments that require ML#'s (25 comments minus 7 stamped files with ML#'s already received).
- CCNP023, CCNP024, and CCNP025 include the .pdf files of the written comments handed in at the meeting, the transcripts from the evening meeting and the transcripts from the afternoon meeting respectively. These files each have an ML# but do not have any of the official receiving stamps. If these files don't need to be stamped, then there are only 15 comments outstanding that will require an ML#.

Hope this isn't too confusing. Please give me a call if I can clarify anything for you.

Please drop me a line to let me know if I should be looking for 124, 18, or 15 files with ML#'s to track these comments.
