**THE DEPARTMENT OF ENERGY'S UPDATED CERTIFICATION OF COMPLIANCE**

The Commission's regulations direct the U.S. Department of Energy (DOE) to certify the availability of documentary material on the Licensing Support Network (LSN) no later than six months in advance of submittal by DOE of its License Application for authorization to construct a geologic repository, and to update this certification at the time DOE submits the License Application. The Commission's regulations further direct these certifications to be made with the Pre-License Application Presiding Officer (PAPO). By Order dated July 7, 2004, the Commission appointed a PAPO. By Order dated July 8, 2004, the PAPO delegated to this Board authority over pre-license application matters related to the LSN.

DOE is submitting today its License Application. Accordingly, appended to this filing is the updated certification of Dong Kim, the LSN Project Manager, DOE Office of Civilian Radioactive Waste Management (OCRWM), who is the official responsible for administration of DOE's responsibility to provide electronic files of documentary material. Additionally, DOE has made available on the LSN a copy of its License Application, with a separate bibliographic header and redacted image for the appendix to the License Application that contains Official Use

Only information. The portion of the License Application with classified information is not represented on the LSN pursuant to the Commission's regulations. DOE will continue to supplement its LSN collection consistent with the Commission's applicable regulations and PAPO Board Orders.
