Nine Mile Point Nuclear Station, LLC (NMPNS) hereby transmits revised information in support of previously submitted requests for amendment to Nine Mile Point Unit 1 (NMP1) Renewed Operating License DPR-63 and Nine Mile Point Unit 2 (NMP2) Renewed Operating License NPF-69. The initial requests, both dated July 12, 2007 (References a and b) proposed to revise NMP1 and NMP2 Technical Specifications (TS) regarding control room envelope habitability in accordance with Technical Specification Task Force Traveler 448, Rev. 3. The initial requests stated that the amendments would be implemented within 60 days of NRC approval. It has been NMPNS' intent to implement the amendments concurrently due to commonality of the new control room envelope habitability program between the units.

The NRC has recently approved TS Amendment 125 for NMP2 to permit use of an alternative radiological source term (Reference c). The approved implementation period for Amendment 125 is 120 days. The TS sections affected by this amendment overlap with the proposed changes contained in the NMP2 control room envelope habitability amendment request.

To avoid the potential difficulties created by implementing a later amendment (control room envelope habitability) before an earlier amendment (alternative source term), NMPNS proposes to increase the implementation period for both of the proposed control room envelope habitability amendments from 60 to 120 days. This change would allow concurrent implementation of both control room envelope habitability amendments with or after the NMP2 alternative source term amendment.

This change in implementation periods does not affect the No Significant Hazards Determination analysis provided by NMPNS in References (a) and (b). Pursuant to 10 CFR 50.91(b)(1), NMPNS has provided a copy of this letter to the appropriate state representative. This letter contains no new regulatory commitments.
