I am writing you because I oppose the EnergySolutions proposal to bring 20,000 tons of nuclear waste from Italy to Oak Ridge, TN.

I am a recent Vanderbilt graduate, and I now work at Vanderbilt's Environmental Management and Sustainability Office. I have lived in TN for most of my life and would hate to see so-called "low-level" or "intermediate-level" nuclear waste from anywhere, let alone another country, threaten the lives of Tennesseans.

The waste processing would likely leave the areas hopelessly contaminated federal Superfund sites. The shipping of such waste also threatens many Americans, as an accident on waterways, highways, or railways would be extremely dangerous.

Please do not allow foreign waste to threaten American lives.
