FOIA REQUEST

Dear FOIA Officer:

On behalf of Public Citizen, and pursuant to the Freedom of Information Act, 5 U.S.C. § 552, I request a copy of any logs or other record-keeping systems of Freedom of Information Act requests since January 1, 2004.

If responsive records are available in both electronic and paper formats, I would prefer them to be provided in electronic format.

If your agency determines that I should be charged for any part of this request, please contact me before any searches reach an estimated cost of \$25.

If you refuse access to any of the requested records, I ask that you describe the materials you are withholding and state the basis for the denial for each document being withheld. In addition, please state the number of pages in each withheld document, the date of each document, and the total number of pages pertaining to this request. Please provide copies of any logs, internal tracking numbers or other file-tracking device or system of documents in existence but denied disclosure. This information will be helpful in deciding whether to appeal an adverse determination.

If part of a record is exempt from disclosure under FOIA, the law requires you to release all non-exempt portions. Please describe in detail any omitted, deleted, or redacted material and specify your reasons for believing those portions of the records are exempt from disclosure.

I look forward to receiving your response within 20 working days, as required by law, and will interpret any delay in your response as a denial of this request. I certify that the previous statements are true and correct to the best of my knowledge and belief, and ask for your prompt attention to this matter.
