Mike,

Per 10 CFR 2.390, AREVA had not provided an affidavit and had not properly marked its April 30, 2008, letter to the Chairman. Prior to our meeting with them on June 5, I had asked Dr. Dorothy Davidson, VP AREVA, if AREVA would be able to resubmit the letter with the proper markings and provide an appropriate affidavit. She said that she would check with Mr. Michael McMurphy, President and CEO of AREVA, and get back to me. At the June 5th meeting, Dr. Davidson and Mr. Alan Hanson of AREVA said that Mr. McMurphy had indicated to them that rather than AREVA resubmitting a properly marked letter and providing an affidavit, the NRC should make the letter public. Mr. McMurphy's e-mail below confirms this. Therefore, the package that contains AREVA's letter and our response (ML081360516) should be declared "public" in ADAMS. However, before doing this I recommend that the second last sentence in AREVA's letter, which requests the NRC to handle the letter as proprietary, and the proprietary markings on our response, be crossed out.
